

Terms & Conditions of Sale:-

- a) All the interested Bidders can attend the Auction on schedule date and time.
- b) All Bidders who intend to attend Auction will have to register themselves with the Commandant 55 Battalion BSF, Panisagar, Tripura (North), Tripura one hour before Auction;
- c) All Bidders will have to deposit a sum of Rs. 5,000/- (Rupees five thousand) only as Security Money before Commencement of the Bid. The Security Money, so deposited will be returned/adjusted immediately after the Auction is over;
- d) The highest acceptable responsive Bidder will have to deposit 100% cost of Stores on the spot plus GST 18% as applicable in Tripura State, in cash and will lift the Stores immediately after Auction, at his own arrangements;
